Tested BOP 4/23/13. Pressure held to 3000# for 30 minutes. ✓ Casing tested 4/23/13. Pressure held to 1500# for 30 minutes. No pressure drop. ✓

Started drilling out cement at 474'TVD/MD on 4/24/13. ✓
