Basin Mancos: First produced on 3/17/2013 during flowback. Well flowed 0 BO, 131 BW, and 0 gas in 6 hours. A subsequent sundry will be filed upon recovery of the frac load. Well blew dead before recovering any hydrocarbons; only recovered frac water and nitrogen.


Basin Dakota: First produced on 3/25/2013 during workover. Recovered 2.6 BO, 84 BW, and Gas TSTM in 8.5 hours. The water recovered is frac water.


