Logos Operating, LLC politely requests a pit closure extension of an additional 30 days to allow the chloride levels to be reduced by blending clean soil with the pit materials (3:1 ratio). The pit closure extension ends on 7/2/2013 and this request would extend the closure date to 8/2/2013. It is likely that the reduction in chloride levels will be reached before the end of the 30-day extension, and if that is the case, Logos will accelerate the pit closure accordingly.
