On 5/30/13 tested BOPs, choke manifold, and 8 5/8" 24# J-55 casing. Tested Pipe Rams, Blind Rams, choke Manifold, Choke Line, Kill Line, and T/W Valve at 250 psi for 5 minutes then 2000 psi for 10 minutes. All passed. Tested surface casing to 600# for 30 minutes, tested O.K., Tagged cement @ 90' KB, drilling ahead.
