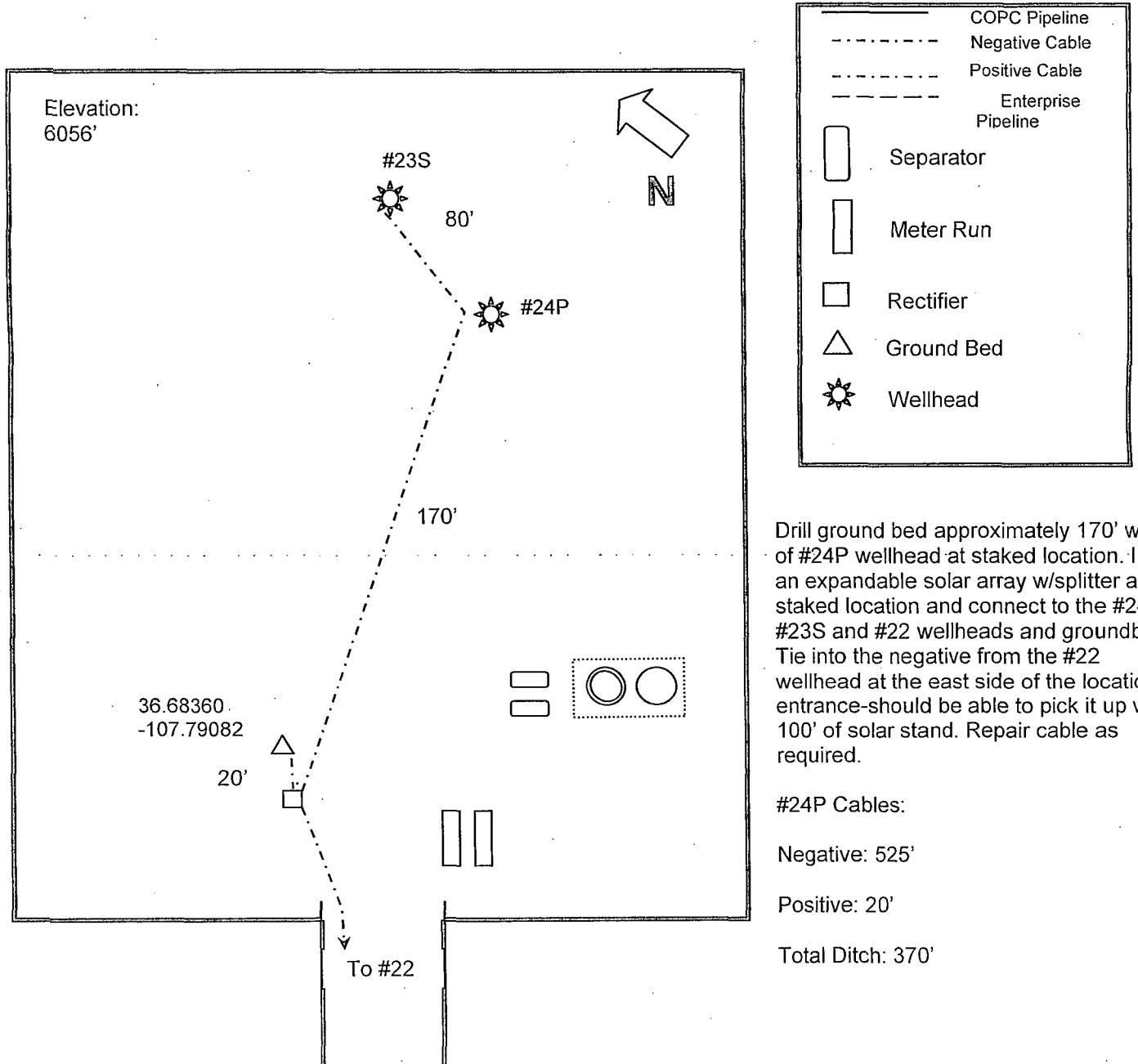

Unit letter F, S33, T29N, R9W, San Juan County, NM



Drill ground bed approximately 170' west of #24P wellhead at staked location. Install an expandable solar array w/splitter at staked location and connect to the #24P, #23S and #22 wellheads and groundbed. Tie into the negative from the #22 wellhead at the east side of the location entrance-should be able to pick it up within 100' of solar stand. Repair cable as required.
