From February 1-6, 2013, HPOC moved in a workover rig and deepened this well from a previous TD of 5566 ft KB in the top of the Entrada formation (the producing zone) to a new TD of 5704 ft KB in the lower Entrada formation. HPOC did not drill this well into the underlying Chinle formation. On February 5, 2013, Halliburton ran logs over the open hole section at the bottom of the well. These logs are attached to this Sundry notice.

present work was done to obtain open hole logs, so the dual completion could be designed properly.


