Elm Ridge Exploration Co LLC spud the above referenced well on 6-19-13. On 6-20-13 we drilled a 12 1/4" hole to 526' and ran 12 joints of 8-5/8" 24# J-55 casing to 519'. We then pumped 370 sks of Premium Class G cement. Circulated 25 bbls of good cement to pit. Pressure tested casing to 600 PSI for 30 plus minutes. Test was good.
