2. TIH w/ 2 3/8" tbg. to csg leak.
3. RU cement crew and PT lines. Establish Injection Rate.
4. Spot a balanced plug to squeeze the leak.
5. PU tbg. and reverse circulate. Pressure up and squeeze.
6. SI tbg. WOC
7. TIH tag TOC. Drill out cement and pressure test to 600 psi for 30 minutes.
8. RDMO
