 7/16/13 - TIH w/ 217 jts., 2 3/8", 4.7#, J-55 tubing, set @ 6,858' (new setting depth) w/ FN @ 6,856'. ND BOPE. NU WH. PT tubing to 1000#. Test OK. RD RR @ 17:00 hrs on 7/16/13.
