Logos Operating, LLC will use as much gas as possible to heat the separators at the battery and to power the pump for the Logos No. 3. Logos anticipates flare volumes of 30-40 mcf per day, or a total volume of 3720 MCF- 4920 MCF. Flaring gas will allow for the continued production and testing of the Logos No. 3 well and assist in the continuing development of BLM Lease NMNM 109387
