The Trading Post 24-2 was returned to production on February 13th, 2013. Maralex failed to report this on a subsequent sundry notice. The well is selling at a marginal gas rate of 2-4 MCFD, but is producing in excess of 100 BWPD. Maralex will continue to dewater this coal seam well.
