Plug 1: MOL & RU. NU BOP. TOOH with 2-3/8" tubing. PU 4-1/2" casing scraper and TIH to 1050'. TOOH. TIH with 4-1/2" retainer and set at 1006'. ^{1185'}
Squeeze 25' sx below retainer and spot 4' sx above retainer to cover Pictured Cliffs top, perforations, and 50' above Fruitland top. PU and reverse circulate with 2 tubing volumes of water. TOOH. plug from 1185' - 905'

Plug 2: With end of tubing at 190', spot 18 sx, or sufficient volume to bring cement to surface inside 4-1/2" casing.

Remediate location in accordance with regulatory agencies' conditions of approval.

Place the Kirrland/Ojo Alamo plug from 466' - 207'




Wellbore Diagram

CONDITIONS OF APPROVAL

1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Lease."
2. Farmington Office is to be notified at least 24 hours before the plugging operations commence (505) 564-7750.
3. The following modifications to your plugging program are to be made:
 - a) Place the Fruitland plug from 1185' – 908'. Place the retainer approximately 50' above the top perf.
 - b) Place the Kirtland/Ojo Alamo plug from 466' - 267'.

You are also required to place cement excesses per 4.2 and 4.4 of the attached General Requirements.
