Set surface casing and cemented 8/2/13. Gelled freshwater mud system.

Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36# J55 LTC. Depth of 12.25" hole from surface to 522'. Casing set from surface to 520'TVD/MD.

On 8/2/13 pumped 190 sks Type III Cement +1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. 20 bbls circulated to surface. WOC 11 hours for surface casing.

BOP tested 8/3/13. Pressure held to 3000psi for 30 minutes. No pressure drop. Casing tested 8/3/13. Pressure held to 1500psi for 30 minutes. No pressure drop.

Float collar at 472'. TOC at surface and BOC at 520'.

Started drilling out float collar and cement 8/3/13.
