Set surface casing string 8/15/13. Gelled freshwater system.

Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" from 0'-540', Casing set from surface to 527'TVD/MD.

On 8/15/13 pumped 182 sks Type III Cement +1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. Circulated 8 bbls cement to surface. WOC 12 hours for surface casing.

Float collar at 483'. TOC at surface and BOC 527'.

Tested BOP 8/16/13. Pressure held to 3000# for 30 minutes. Casing tested 8/16/13. Pressure held to 1500# for 30 minutes. No pressure drop.

Started drilling out cement at 479'TVD/MD on 8/16/13.
