Run bit and scrapper to ~7050'

Set 4.5" cement retainer @ ~6940'.

Squeeze perfs with 25 sacks of cement.

Sting out of retainer and spot 10' of cement.

TOH with tubing.

Pressure test casing to 500 psi.
