
Attached is a drawing for the placement of the cathodic ground, rectifier and cable for the subject well.




## SJ 28-5 #77P

Unit letter D, S27, T28N, R05W, Rio Arriba County, NM



Drill ground bed approximately 195' south of #77P wellhead at staked location. Install a 40-16 rectifier at staked location and connect to #77P wellhead and groundbed. Tie-in to UGAC west of road near Williams Trunk L Tank battery. This will require crossing three Williams lines.

Positive: 20'
