Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" hole from 0-520'. Casing set from surface to 514' TVD/MD.

On 8/30/13 pumped 200 sacks Type III Cement +1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. Circulated 15 bbls cement to surface. WOC 11.5 hours for surface casing.

Float collar at 470'. TOC at surface and BOC 514'.

Tested BOP 8/31/13 to 3000# for 30 minutes. No pressure drop. Tested casing 8/31/13 to 3000# for 30 minutes. No pressure drop. ✓

Started drilling out float collar (tagged at 467') 8/31/13.
