Set surface casing string and cemented 10/16/13. Gelled freshwater mud system.

Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" hole from 0-545'. Surface casing set from surface to 533' TVD/MD.

On 10/16/13 pumped 200 sks of Type III Cement +1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. 10 bbls circ to surface. WOC 11 hours for surface casing.

Float collar at 495'. TOC at surface and BOC at 533'.

Tested BOP 10/17/13 to 3000# for 30 minutes. No pressure drop. Tested casing 10/17/13 to 1500# for 30 minutes. No pressure drop. ✓

Started drilling out float collar (tagged at 490') 10/17/13.
