CIBP's were set at the following depths 6,389', 6,407', 6,562', 6,565', above the Basin Dakota perfs fr/6,596' - 6,777' are temporary. XTO plans to produce from Basin Mancos perfs fr/6,265' - 6,330' to test the Mancos for DHC allocations.

The actual PBTD is 6,990'.

An application to DHC will be submitted at a later date and XTO will obtain the DHC order before commingling.
