Pride Energy preformed a cement squeeze to repair the casing in this well on September 19, 2013 per the following:

Set CIBP above perforations and then isolated casing leak from 872' to 903'. Set 7" packer at 935' and pressure tested 7" casing and liner top down to the CIBP to 600 PSI, held OK. Reset packer at 676' and 676' and pressure tested 7" casing above to 650 PSIG, small wellhead leak. Established rate into casing leak at 1/3 bpm at 500 PSIG. Mix and pumped 50 sxs Class B neat cement down the tubing at 1/2 bpm at 600 PSIG. Displaced cement below packer. Released packer and reversed circulated well clean with 7 bls water. Reset packer at 547' and hesitation squeeze cement. Final squeeze pressure at 800 PSIG. Squeezed approximately 25 sxs outside the casing and left the cement inside at 750'. WOC for 4 days.

Tag cement at 735' and drill out to 930'.

Rig up hot oil truck and pressure test well to 610 PSIG for 30 minutes with no bleed off.
