12/12/13 - Notified Jim Lovato (BLM) and Brandon Powell (NMOCDD) during repair procedure tubing became stuck and was cut off low. There is a water shut off "patch" in the 4 1/2" production casing from 5,629' to 5,652'. The patch will be milled out to fish the remainder of the cut off tubing. The casing patch will not be replaced as the water production is minimal. All cuttings and fluids from the casing patch removal will be circulated back to the flowback tank on location. Verbal approval was received to proceed from Jim Lovato (BLM) and Brandon Powell (NMOCDD).
