

The release occurred on 02/12/14 when the VRT released approximately 5 gallons of oil mist on location, outside of secondary containment. Encana would like to use heavy equipment to excavate approximately 5 cubic yards of impacted soil. Impacted soil will be disposed of at Envirotech's Landfarm. Clean soil and gravel will be brought in from Envirotech to fill in the excavation.


