Energren Resources intends to downhole commingle the Basin DK (71599) and Basin Mancos (97232). The existing DK perforations are 6126'-6223'. A CBL will be run from 6100' to surface to determine TOC. The estimated Gallup perforations are 5265'-5582' at 3spf and will be stimulated in two fracture stages. The well will be cleaned out to PBTD and produced through both zones.
