Huntington Energy, L.L.C. respectfully requests approval to temporarily abandon the above referenced well. The well needs lower line pressure, which is to be obtained through a different gas purchaser who is working to obtain pipeline approvals. This will alleviate the need for compression or to obtain shared compression resulting in the well being commercial. The following is the procedure to TA the well:

- 1) MIRU WOR. ND Tree. NU BOP.
- 2) Install 3000 psi BOP.
- 3) RIH & set CIBP @ 1800'.
- 4) RU pump truck and test casing to 500 psi for 30 min.
- 5) ND BOP. NU valve. RD & Rel all equipment.
- 6) Contact BLM, NMOCD to witness pressure test.
