Pumped 314 sacks of Type III Halcem Cement + 2% bwoc CaCl + 0.125 lbs/sk Poly-E-Flake, yield 1.17 cuft/sk, mixed at 15.8 ppg on 6/23/14. Circulated 15bbbls to surface, WOC 8 hours for surface casing.

Float collar at 502'. TOC at surface and BOC at 528'. ✓

Tested BOP 6/23/14 to 3000# for 30 minutes. Tested casing 6/23/14 to 1500# for 30 minutes. No pressure drop. ✓

Drilled out cement and float collar 6/24/14.
