Work performed: MIRU. Safety Meeting. Tubing 240 psi, casing 30 psi. Bleed well down. NDWH. NU BOP. Pressure test BOP to 500 psi. Unset packer at 1775', run in and latch on to RBP & move up hole to 1752' & reset. Pressure test to 500 psi. ND BOP. NUWH. Test casing & tbg to 500 psi. RD.


