Landed 5-1/2" liner, tapered shoe @ 3413', PBD 3411'. Btm perf 3305', top perf 2932'. Liner top at 2891'. TIH w/4-3/4" plug mill, 2-7/8" regular x 2-3/8" EUE 8rd bit sub w/float, 1 jt 2-3/8" tbg, 2-3/8" SN (1.78" ID) & 55 jts 2-3/8" tbg. Opened well to production tank. Mill out perforation plugs. Ran 2-3/8" x 20' open ended half mule shoe mud anchor and 1/2" weep hole, 2-3/8" SN, & 104 jts 2-3/8" tbg. Tagged at 3408' (3' fill). Cleaned out to PBD of 3411'. Land production tbg, EOT 3329', SN 3307'. Ran pump and rod string, stroked pump and started pmpg unit. Put well back on production.
