





Plugging Program for West Bisti Coal 22 Com 1T

- 1) MOL RU. TIH with tubing.
- 2) With end of tubing at 1206', mix and pump 143 sx cement, or sufficient volume, to bring cement to surface inside 5-1/2" casing.
- 3) Cut off well head 4 feet below surface and remediate location in accordance with regulatory agencies' conditions of approval.
