13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Burlington Resources proposes to utilize a closed loop system to accommodate a liner clean out on the subject well. Plans are to pull tubing and liner, clean out and underream open hole section, run new liner, production tubing and BHA, install rod pump & return to production. Plans include connecting a blooie line to the steel tank to handle any flowback fluids. For that reason a NMOCD-depression/BLM-pit is needed to help facilitate the flow into the tank. The start of the NMOCD-depression/BLM-pit will be located approximately 100' from the wellhead, approx. 6' deep x 10' wide x 40' long, with a ramp for a truck to set the tank. It will be filled with stockpiled soil once the rig has moved off. As a safety precaution we will line the NMOCD-depression/BLM-pit with plastic before laying down the blooie line. We don't anticipate any fluids in this NMOCD-depression/BLM-pit; all fluids will be fed into the steel tank.

The NMOCD was consulted and they concluded the depression is not deemed a pit.
