This exception is requested for the following reasons: WPX Energy requests authorization to flare this well due to a high nitrogen content above acceptable Beeline Gas Systems standards due to nearby frac activity on the NE CHACO COM #176H, and NE CHACO COM #177H that occurred on 12/1/14. As a result, the NE CHACO COM #239H is experiencing crossflow. WPX has approval to flare this well until 12/31/14, but expect that the well will not be cleaned out by that time. The well could flare for up to 30 additional days of the current flare extension deadline if given approval. Pipeline quality gas should be obtained within 30 days of approval. A gas sample is being collected and sent to a third party for a gas analysis. The results of the gas analysis will be submitted upon receipt.

The well flows to Beeline Gas Systems at a rate of 215 MCF/D.
