

APPLICATION FOR EXCEPTION TO NO-FLARE RULE 19.15.18.12

B. Based upon oil production of **250** barrels per day, the estimated volume

of gas to be flared is **450 MCF/D**; Value: **\$1238** per day.

D. Distance 6,982' Estimated cost of connection \$488,740

E. This exception is requested for the following reasons: WPX Energy requests authorization to flare this well for 30 additional days due to the inability to flow the gas through a pipeline. WPX anticipates for the Chaco Trunk 3 Extension 2 pipeline to be constructed by 3/16/15. WPX will not have completed construction by the time the emergency flare extension expires (2/15/15). We are currently waiting for ROW approval from the BLM. As a result, WPX is requesting flare authorization for this well until the anticipated date of pipeline completion.
