

WPX Energy requests authorization to flare this well for 30 additional days due to the inability to flow the gas through a pipeline. WPX anticipates for the Chaco Trunk 3 Extension 2 pipeline to be constructed by 3/16/15. WPX will not have completed construction by the time the emergency flare extension expires (2/15/15). We are currently waiting for ROW approval from the BLM. As a result, WPX is requesting flare authorization for this well until the anticipated date of pipeline completion.
