

Stage 1 Lead: Cement (pumped 12/22/14) 497 sks Premium Lite FM+ 3% CaCl2 + 0.25/sk Cello Flake + 5#/sk LCM-1 + 8% Bentonite + 0.4% FL-52A + 0.4% Sodium Metasilicate. Mixed at 12.1 ppg. Yield 2.13 cuft/sk.

Stage 1 Tail: Cement (pumped 12/22/14) 377 sks Type III Cement + 1% CaCl2 + 0.25#/sk Cello Flake + 0.2% FL-52A. Mixed at 14.6 ppg. Yield 1.38 cuft/sk. No returns to surface. WOC 9.5 hours. Completions will run a CBL prior to operations.

Tested BOP 12/22/14 to 3000# for 30 minutes. No pressure drop. Tested casing 12/22/14 to 1500# for 30 minutes. No pressure drop. ✓
