

Pumped 247 sacks of Type III Halcem Cement + 2% bwoc CaCl + 0.125 lbs/sk Poly-E-Flake, yield 1.17 cuft/sk, mixed at 15.8 ppg on 12/18/14. Circulated 25 bbls to surface. WOC 7 hours for surface casing.

Float collar at 489'. TOC at surface and BOC at 530'. ✓

Tested BOP 12/18/14 to 3000# for 30minutes. No pressure drop. Tested casing 12/18/14 to 1500# for 30 minutes. No pressure drop. ✓
