

Hole diameter: 6.125", production string diameter: 4.5", production string weight and grade: 11.6# SB80 LTC. Depth of 6.125" hole from 5905'-11,288'MD. Float shoe at 11,286'MD. Float collar at 11,285'MD. Production liner set from 5800'-11,288'MD.

Pumped (11/12/14) 296 sacks Premium Lite High Strength FM + 0.7% bwoc R-3 + 3% bwoc Potassium Chloride + 0.25lbs/sack Cello Flake + 0.5% bwoc CD-32 + 1.15% bwoc FL-52A + 60 lbs/sack Calcium Carbonate + 124.4% Fresh Water. Yield 2.63 cuft/sk. Circulated 40bbls to surface.
