July 29 2003: Dug out old well head. Remove temporary cap, fill 4 1/2" casing with 11 sacks (5.5 cf) quickcrete. Weld on dry hole marker on 4 1/2" casing stub. Fill bell hole and level area around dry hole marker. This completes rehab requirements for this well bore. Location will be reclaimed when the Owen #2R is plugged and abandoned. This sundry was sent to the BLM in August 2003.
