

BP America Production Company respectfully requests to deepen & install liner in the subject well. Although we believe the Blanco Pictured Cliffs will be non-productive in the well without perforation & fracture stimulation, BP will also pursue downhole commingling of the Basin Fruitland Coal & Blanco Pictured Cliffs formations.

The Basin Fruitland Coal (71629) & the Blanco Pictured Cliffs (72359) pools are pre-approved for DHC per NMOCD Case No. 12346; Order No. R-11363 effective 04/26/2000. The interest owners are not identical in the subject well therefore notification is required. Burlington Oil & Gas and WPC Oil & Gas are the working interest owners in the Basin Fruitland Coal of the subject well and were notified by certified mail. BP owns 100% of the Pictured Cliffs formation. Please see attached Land Letter.

BP will not perforate or hydraulic fracture the subject well in the Blanco Pictured Cliffs formation. The exposed Blanco Pictured Cliffs formation will be covered by an un-cemented liner and again will not be stimulated, therefore we are allocating the production as follows: Blanco Pictured Cliffs= Oil 0%, Gas 0%, and Water 0%, and Basin Fruitland Coal= Oil 100%, Gas 100%, and Water 100%. The basis for this allocation is solely contributed to offset production.

Commingling production downhole in the subject well from the proposed pools will not reduce the value of the total remaining production. Please see attached Deepening procedure, wellbore schematics & C-102 plats.


1. Pull tubing




