If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **5/2/15**, given approval. The well would flare for up to 30 days. Pipeline quality gas should be obtained within 30 days. A gas sample will be collected upon the confirmation of cross flow and sent to a third party for a gas analysis. The results of the gas analysis will be submitted upon receipt.
