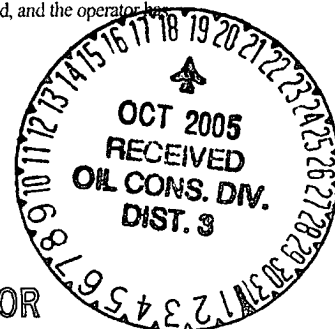
13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. If the operation results in a multiple completion or recompleat in a new interval, a Form 3160-4 shall be filed once testing has been completed. As soon as possible - we intend to locate and cement squeeze a casing leak in the above well as follows.

1. MIRU WSU. NDWH. NUBOP
2. Tag for fill - POOH w/ tubing.
3. TIH w/ RBP and Packer on Work string.
4. Locate leak - establish pump-in rate and pressure.
5. Based on (4) pump suffieint cement to squeeze off leak.
6. Allow cement to cure 24 hours- POOH with packer.
7. Drill out cement and pressure test casing to 500 PSIG for 30 minutes.If squeeze holds proceed below- if not goto (4.)
8. Clean -out to PBTD.
9. TIH w/ production tubing and NDBOP. NUWH.
10. RDMO WSU.
11. RTP.
