Cement with 125 sks Class B, 2% CaCl2, 1/4#/sk flocele (148 cu.ft.). Plug down @ 6:00 pm on 10/02/05. Circulate 8 bls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
