5/17/15 - Run 113jts, 4-1/2", P-110, 11.6#, LT&C. 8RD, CSG set @ 10870', LC @ 10778', RSI tools 10767', TOL @ 5909'.

5/18/15 - R/U rotating cement head and lines & psi tested to 7000pis. Halliburton cmt 4.5 liner with spacer/flush (10bbbls/H2O + 40bbbls/chem spacer + 10bbbls/H2O), followed by primary cmt @ 13.3# (133.2bbbls/495sx of Extendacem system) Displaced w MMCR & 2% KCL of 330bbbls. Landed plug @ 1600psi & bumped to 2600psi and hole. Floats held-1.5bbbls back on bleed off plug down 07:58hrs. Dropped ball and set hanger @ 3860psi. Released & landed 4.5" casing string on versaflex hanger from TOL @ 5882' MD to 10870'. Circulated top of liner clean (28bbbls of cement to surface). PSI tested versaflex hanger seals and 4.5 csg to 1500psi for 30mins- tested good and recorded on Halliburton chart.
