5/24/15 - Run 117jts, 4-1/2", P-110, 11.6#, LT&C. 8RD, CSG set @ 11425', LC @ 11332', RSI tools 11319', TOL @ 6113'.
Test lines to 6000/psi, start pumping @ 4bbls/min 10bbls of FW, 40bbls Tuned spacer @ 10.5ppg YD 6.15, 41.1gal/sx, 10bbls of FW, Lead 515sx (124.7bbls) mixed @ 13.3ppg, YD 1.36cuft/sx, water 6. Gal/sx, additive: 50% POZ, 0.3% Halad-D9. 0.05% SA1015, 0.7% Halad-413, 2.5# KOLSEAL, pump 10bbls of FW to pit to clear lines. Shut down. Dropped Dart, Displaced w/ 40bbls of MMCR, 40bbls 2% KCL (inhibited), 20bbls of FW, 38.8bbls 2% KCL, Total 138.8bbls, Bumped Plug @ 02:50 on 5/24/15 to 2200psi, prior psi 1550, bled back 1.25bbls floats held, Dropped 1.75setting ball, Pressure up 3815psi, set liner, pulled up to (220k) 50K over, slacked off to neutral, confirm tool set, rotate and release set tool. Circulate @ .5bbls/min pull out of liner then raise rate to 6bbls/min, Roll hole w/ 180bbls KCL. After tuned spacer shut annular and divert to blow tank. Circulated 30bbls good cement back to surface, with annular shut pressure up to 1500psi and hold for 30min - good test. Bleed off psi, RD HES, LD cement head.
