

Describe Cause of Problem and Remedial Action Taken.*

Upon excavation of the BGT, soil samples indicated elevated hydrocarbons in the underlying soil. Soil samples were taken to a depth of 36" and lab results came back with TPH (418.1) at 2,000 ppm. The elevated levels are from historic permitted operational practices prior to the installation of a below grade tank.

Describe Area Affected and Cleanup Action Taken.*

The affected area is unknown at this point. The immediate plan is to take perimeter samples to delineate the horizontal extent and excavate down to determine vertical extent. Onsite analysis for TPH levels will be recorded until TPH levels are below 1,000 ppm, or competent bedrock is encountered - as approved by NMOCD.
