In reference to the BLM letter dated June 5, 2013, Running Horse Production, LLC is requesting to leave the Frontier A#1 SWD (Lease NMSF08008) shut-in through October, 2016. This is due to the lack of exploration and production activity in the area. Produced water volumes have not been sufficient to warrant operation and injection of this well. Running horse is evaluating future exploration and production plans in this area in light of our recently drilled Tenneco Federal #1R well, and requests maintaining this well for future injection activities. A mechanical integrity test (MIT) was performed on the well in November 2011. The results from this MIT indicated no mechanical issues with the well. Running Horse will continue to operate this well in accordance with the Navajo Nation EPA UIC permit requiring MITs every five years. The next MIT is scheduled for November, 2016.
