RU Blue Jet to run a casing inspection log from 6450' to surface. 7/23/15 RIH w/mill & milled out CBP @ 8108', 8176' and tagged up @ 8340' (top perf). Circ. hole w/2% KCL, foamer and corrosion inhibitor cleaning out fill. 7/24 RIH w/4-1/2" CIBP & set @ 8290'. Topped CIBP w/8 sx Portland cement Class I-II cement (1.18 cf/sx). RD W/L and landed tubing hanger. ND BOP, NU WH. RD & released rig @ 1900 hrs 7/24/15. Plans to P&A the well as soon as rig is available.
