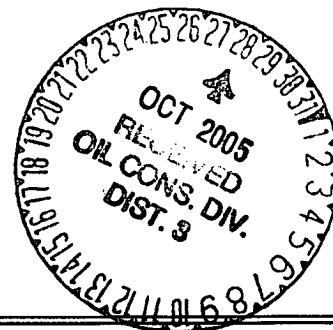

10/17/05 Spud well @ 8:00 am on 10/17/05. Drill a 8-3/4" hole to 142'. Ran 3 jts. 7" 20# K-55 casing, set @ 139'. RU Halliburton. Cement with 50 sks Class B, 2% CaCl2, 1/4#/sk floccle (59 cu.ft.). Plug down @ 2:15 pm on 10/17/05. Circulate 2 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing and BOP to 600 psi - ok.
