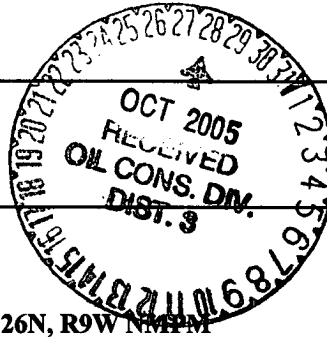

10/18/2005 MIRU MOTE #1. Spud 8-3/4" hole @ 09:00 hrs 10/18/05. Drill ahead to 221'. Circ. & condition hole w/ air mist. RIH w/ 13 jts 7", 20#, J-55 ST&C csg & set @ 218'. Pumped pre-flush of 4 bbls H2O, then pumped 50 sx (81 cf - 14.5 bbls slurry) Type 1-2 Portland cmnt. w/ 20% flyash & 14.5 ppg into csg. Dropped plug and displaced w/ 7.2 bbls H2O, no cmnt. to surface. WOC. NU WH. RD & released rig. PT will be conducted by the drilling rig before drilling continues.
