Pumped pre-flush of 4 bbls H2O, then pumped 59 sx (95 cf - 17 bbls slurry) Type 1-2 Portland cmnt. w/ 20% flyash & 14.5 ppg into csg. Dropped plug and displaced w/ 9 bbls H2O, circ. 2 bbls cmnt. to surface. WOC. NU WH. RD & released rig. PT will be conducted by the drilling rig before drilling continues.
