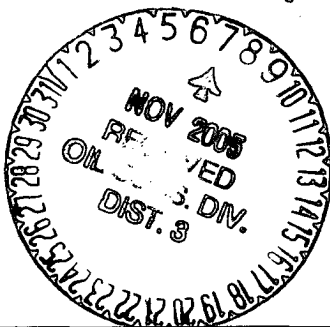

10/21/05 Spud well. Drilled 12 1/4" hole to 159', ran 9 5/8", 36#, J-55 STC casing, landed @ 148'. Cemented with 96 sks Type III cement plus 3% CaCl₂ plus 0.25 lb/sk Celloflake, yield 1.28, 122.88 cu. ft. We ran centralizers on all joints. Circulated 12 BBLs good cement to surface. Wait on Cement 12 hours. 10/22/05 Tested BOPs 250# low and 2000# high for 10 minutes each. Tested 9 5/8" casing to 600# for 30 minutes, held O.K. Tagged cement @ 90'.
