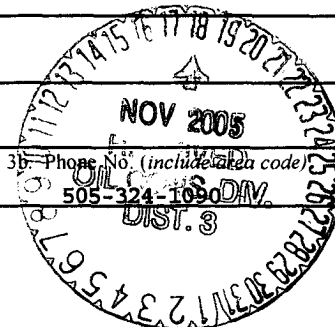

Cmt'd prod csg w/330 sx type II cmt w/4% gel, 0.2% CD32, 0.5% FL52, 2% Phenoseal & 1/4 pps celloflake (12.5 ppg & 2.01 cuft/sx) followed by 100 sx Prem Lite HS cmt w/0.2% CD32, 0.5% FL52, 2% Phenoseal & 1/4 pps celloflake (14.2 ppg & 1.54 cuft/sx). Circ 40 bbls cmt to surf. Cmt'd 2nd stage w/525 sx Type III cmt w/8% gel, 2% Phenoseal, 1/4 pps celloflake (11.4 ppg & 3.03 cuft/sx) followed by 100 sx Type III cmt (14.5 ppg & 1.39 cuft/sx). Circ 105 bbls cmt to surf.

Prod csg will be PT at completion.
